

1. INTRODUCTORY PROVISIONS

1.1.On October 22, 2018, the Contracting Parties entered into the Electronic Information Resource Agreement which defines the conditions of cooperation and rights and duties of the Contracting Parties while providing defined Materials (hereinafter referred to as the "Agreement"). Agreement was published in the Register of Contracts on October 24, 2018 with the ID of contract 6550503 and eventually amended by Amendment No. 1, No. 2., No. 3. and No. 4.









- 1.2. Due to the fact that according to Appendix D of the Agreement, paragraph "Subscriptions to titles transferred into Publisher from another publisher will be added to NTK and/or Participating Institution's Core Collection in the first year of transfer if NTK and/or Participating Institutions have one or more subscriptions for the calendar (or subscription) year in which the title is transferred.", the Contracting Parties decided to include from January 1, 2020 new Title into the Core Collection of
 - Mendel University in Brno

which will have an effect on the price


the Contracting Parties execute this Amendment.

2. SUBJECT-MATTER OF THE AMENDMENT

2.1. The Contracting Parties have agreed that Appendices A and E to the Agreement shall be modified in relation to the Participating Institution Mendel University in Brno as specified in the Appendices No.1 and No.2 to this Amendment.

3. FINAL PROVISIONS

- 3.1. The Amendment shall become valid on the date of signature by both Contracting Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts, as amended. The Amendment will be published by Licensee in the Register of Contracts. The Amendment contains business secrets pursuant to the provisions of Section 504 of Act No. 89/2012 Coll., the Civil Code, as amended, which will not be disclosed in the Register of contracts in accordance with provisions of Section 3, Paragraph 1 and Paragraph 2 letter b) of Act No. 340/2015 Coll. (the fees of the individual Participating Institutions).
- 3.2. All other provisions of the Agreement shall remain unaffected.
- 3.3. The Parties declare and confirm that they acted pursuant to the changes introduced by this Amendment already as of 1 January 2020. Thus, where applicable, the changes stipulated in this Amendment were applied as of 1 January 2020. Any previous performance non-compliant with this Amendment will be subsequently settled by the Parties, if necessary.
- 3.4. The Amendment is compiled in three counterparts in the English language, each of which has the power of an original. Suweco shall receive one counterpart and NTK shall receive two counterparts.
- 3.5. The Contracting Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and affect under law.
