WHEREAS, Customer and Licensor entered into a license agreement with License ID 34459, dated 13 November 2018, regarding the licensed Products as defined therein (the "License Agreement"); as last amended 19 March 2019; the License Agreement was published in the Register of Contracts on 16 November 2018 with the ID of contract 6776283;

WHEREAS, Customer and Licensor desire to continue the License Agreement under the same Terms and Conditions set forth therein, except as expressly modified herein;

THEREFORE, the parties agree that all provisions of the License Agreement are hereby incorporated into this Amendment and made a part hereof, subject to the following modifications:

1. The License Agreement shall be amended to modify the conditions in section 3. Optional renewal as follows:

The wording

*"Customer shall have the option to renew the Term for additional one-year terms, for the number of*

*years indicated in Section 1 above, for the fees indicated with respect to each such year. Such option is subject to the condition that Licensor receive written notification of Customer's exercise of its option for each renewal term no later than 90 days prior to the end of the current year of the Term."*

is replaced as follows:

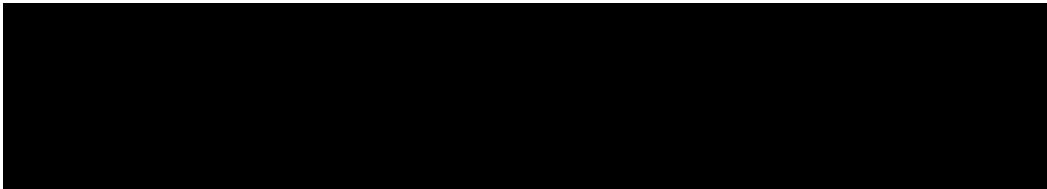
*"Customer shall have the option to renew the Term for additional one-year terms, for the number of years indicated in Section 1 above, for the fees indicated with respect to each such year. Such option is subject to the condition that Licensor receives written notification of Customer's exercise of its option for each renewal term no later than 30 days prior to the end of the current year of the Term."*

2. All other terms and conditions of the License Agreement not expressly modified by this Amendment shall remain in full force and effect.

**MISCELLANEOUS**

1. This Amendment shall become valid upon being signed by both parties. The Amendment shall become effective on the date of its publication in the Register of Contracts in accordance with the conditions laid down by Act No. 340/2015 Coll., On the Register of Contracts, as amended. The Amendment will be in this register published by the Customer.
