1. INTRODUCTORY PROVISIONS

- 1.1. On the 10 January 2023 the Contracting Parties entered into the Standard License Agreement (hereinafter referred to as the "**Agreement**").
- 1.2. The Agreement defines conditions of cooperation and rights and duties of the Contracting Parties while providing defined Licensed Materials that are set forth in Appendix A (Business Terms) of the Agreement to the Licensee and Participating Institutions listed in Appendix B (Participating Institutions, Potential Participating Institutions and Fees) to the Agreement in Appendix C (IP Addresses of Participating Institutions) to the Agreement and Appendix D (Title List) to the Agreement.
- 1.3. The Agreement was published in the Register of Contracts on 11 January 2023 with the ID of contract 21474513.
- 1.4. The Contracting Parties have agreed that selected Participating Institutions of the Agreement will upgrade their subscription of individual collections to the JSTOR Archival Journals and Primary Sources Collection (Full Access Collection), with the start of the upgrade being on 1 January 2024, without any changes to the Fees for the subscription years 2024 and 2025.

2. SUBJECT-MATTER OF THE AMENDMENT

- 2.1. The Contracting Parties have agreed that Appendix A: Business Terms, section Licensed Materials, shall be modified as follows (the altered part is highlighted):
 - (a) The wording "Beginning on 1 January 2024, all Participating Institutions with the exception of National Museum

National Library of Technology

Education and Research Library of Pilsener Region

and Museum of West Bohemia,

shall have access to the Full Access Collection without any change to the Fees included in the section Fees and Negotiated Discounts of this Agreement." will be added.

(b) The wording "The JSTOR Archival Journals and Primary Sources Collection (Full Access Collection) contains the following 27 Collections:

are subsets of the abovementioned 27 Collections and are also fully covered by The JSTOR Archival Journals and Primary Sources Collection (Full Access Collection)." will be added.

3. FINAL PROVISIONS

- 3.1 This Amendment shall become valid on the date of signature by both Contracting Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts, as amended. This Amendment will be published by the Licensee in the Register of Contracts. The Amendment contains business secrets pursuant to the provisions of Section 504 of Act No. 89/2012 Coll., the Civil Code, as amended, which will not be disclosed in the Register of Contracts in accordance with Section 3 (1) and (2) letter b) of Act No. 340/2015 Coll. (the fees of the individual Participating Institutions).
- 3.2 All other provisions of the Agreement shall remain unaffected.

- 3.3 The Amendment itself shall be signed by the authorized signatory of the Licensor and the Licensee.
- 3.4 This Amendment is executed in electronic version and each Party receives one electronic counterpart.
- 3.5 The Contracting Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under law and each Contracting Party declares that the electronic execution is valid and effective in the jurisdiction the Contracting Party executes the Amendment.


